2025 Assessments & Payment Information

The 2025 HOA assessments will remain at \$95.00 per quarter. Your HOA payments are due the 1st day of the quarter they are billed (January, April, July, October). If dues are not paid within 30-days of the billing date, a quarterly fee equal to 5% of the quarterly assessment will be added to any delinquent assessment.

If you plan to pay by check, be advised that the HOA dues payment must be made payable to the Association (EPGCHA) and include your account number. All checks must be sent to the Payment Lockbox address listed below. It can also be found on the bottom of your statement.
